





COVID-19

Response & Precautionary Measures

The Aroostook House of Comfort would like to ensure that our patients, volunteers, staff, and community are safe from Covid-19. We are taking every precaution within our facility to avoid exposure and take preventive actions daily to stop the spread of the virus. We are following the guidelines issued by the CDC to help minimize any potential health risks.

We have implemented a visitor screening process with the following policies:

- Visitors are screened before entering the hospice house for fever, cough, shortness of breath, sore throat, and travel history.
- Visitors are required to wash their hands in the family restrooms before entering the patient's room.
- Masks are mandatory and must be worn at all times.
- Children under the age of 12 are permitted entry only under certain circumstances. Please check with a staff member or administration.
- Two visitors at a time are allowed in the patient's room. Others are asked to wait outside the facility or in a vehicle parked on the premises. Please check with a staff member or administration for other options.
- Once in the building, visitors are asked to remain in the waiting area. At this time visitors are not allowed in the family area, children's playroom, or the kitchen area.

















Meet Our Board - Nancy Cronkite


















Welcome Dr. David Jones to Our Board of Directors

David D. Jones MD, FAAFP, was born and grew up in Boston in a medical family, went to Swarthmore College, and then the University of Vermont Medical School. His medical training was at the Maine Dartmouth Family Practice Residency in Augusta. Dr. Jones subsequently practiced Family Medicine and Emergency Medicine in Aroostook County starting in 1981 and moved to Aroostook County in 1982 to help found Aroostook Family Practice in Presque Isle. He also continued to practice Emergency Medicine and had a large nursing home practice. As his Family Practice patients and he aged, Hospice Medicine became a natural part of his practice. He became the Hospice Physician for Visiting Nurses of Aroostook/EMHS (Northern Lighthouse Home Care and Hospice) in 2005 while continuing to practice Family Medicine in Presque Isle and Emergency Medicine in Fort Kent. Dr. Jones also served on the Board of Medicine for eight years during this time. Now, as he retires from Emergency Medicine and his other work obligations, Dr. Jones will continue to practice as the Hospice Physician for Northern Maine and the Medical Director for the Aroostook House of Comfort.




